

**ORDINANCE NO. 2017-03**

**AN ORDINANCE TO REPEAL AND REPLACE ORDINANCE NOS. 1-85, 1-85(A), 1-90, 2012-01, AND 2014-01 BY CONSOLIDATING INTO ONE ORDINANCE ALL STOP INTERSECTIONS IN THE TOWNSHIP OF MOUNT PLEASANT, ADAMS COUNTY, PENNSYLVANIA**

**WHEREAS**, on January 31, 1985, Mount Pleasant Township Board of Supervisors adopted Ordinance No. 1-85 establishing numerous stop intersections in Mount Pleasant Township; and

**WHEREAS**, on November 25, 1988, Mount Pleasant Township Board of Supervisors adopted Ordinance No. 1-85(A) establishing numerous stop intersections in Mount Pleasant Township; and

**WHEREAS**, on March 29, 1990, Mount Pleasant Township Board of Supervisors adopted Ordinance No. 1-90 establishing numerous stop intersections in Mount Pleasant Township; and

**WHEREAS**, on February 23, 2012, Mount Pleasant Township Board of Supervisors adopted Ordinance No. 2012-01 establishing numerous stop intersections in Mount Pleasant Township; and

**WHEREAS**, on September 25, 2014, Mount Pleasant Township Board of Supervisors adopted Ordinance No. 2014-01 establishing numerous stop intersections in Mount Pleasant Township; and

**WHEREAS**, the Mount Pleasant Township Board of Supervisors desire to repeal and replace Ordinance Nos. 1-85, 1-85(A), 1-90, 2012-01, and 2014-01 to consolidate the stop intersections into one Ordinance and add additional stop intersections and other traffic control provisions; and

**WHEREAS**, the additional stop intersections are located in the Wheatland Acres development where the Developer has offered for dedication to Mount Pleasant Township the streets set forth in Resolution Nos. 17-15 and 23-16; and

**WHEREAS**, the streets offered for dedication include the following stop intersections:

Intersection of Wheatland Drive (T-495) and West Crest View Lane (T-497)

Intersection of West Crest View Lane (T-497) and West Crest View Lane (T-497)

Intersection of West Crest View Lane (T-497) and Meadow Way (T-413). Stop signs shall be erected on both streets and on both sides of West Crest View Lane

Intersection of Wheatland Drive (T-495) and Meadow Way (T-413)

Intersection of Crest View Lane (T-497) and Country Drive (T-412)

Intersection of Carriage Lane (T-499) and Country Drive (T-412)

**NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Mount Pleasant Township, Adams County, Pennsylvania, and it is enacted and ordained as follows:**

**Section 1.** The following intersections are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching on a Township road intersecting with a State Road, or in the case of two intersecting Township roads, to face traffic approaching the second-named street. Every driver of a vehicle approaching the intersection on the second named or stop street, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Vehicle Code, as amended or supplemented, and shall not proceed into or across the first-named or intersecting or through street until the driver has followed all applicable requirements of that section of the law.

Intersection of (T-493) Fleshman Mill Road and (T-494) Kohler School Road.

Intersection of (T-493) Fleshman Mill Road and (T-443) Cedar Ridge Road.

Intersection of (T-440) Beck Road and (T-485) Spook Lane – stop signs shall be erected on both sides of Spook Lane.

Intersection of (T-428) Storm's Store Road and (T-485) Spook Lane.

Intersection of (T-428) Storm's Store Road and (T-491) Stone Bridge Road.

Intersection of (T-489) Salem Church Road and (T-490) Mason Road.

Intersection of (T-424) Low Dutch Road and (T-489) Salem Church Road.

Intersection of (T-489) Salem Church Road and (T-488) Whisler Road.

Intersection of (T-440) Beck Road and (T-491) Stone Bridge Road.

Intersection of (T-487) Tall Oaks Road and (T-488) Whisler Road.

Intersection of (T-424) Low Dutch Road and (T-421) Willow Road.

Intersection of (T-442) Locust Lane and (T-439) Spring Lane.

Intersection of (T-655) School House Road and (T-444) Flat Bush Road.

Intersection of (T-439) Hoffacker Road and (T-444) Flat Bush Road.

Intersection of (T-439) Hoffacker Road and (T-445) Kuhn Road.

Intersection of (T-491) Stone Bridge Road and (T-494) Kohler School Road.

Intersection of (T-494) Kohler School Road and (T-493) Fleshman Mill Road.

Intersection of Tall Oaks Road (T-487) at "Y" on Bon-Ox Road – stop signs shall be erected at both ends of the "Y".

Intersection of (T-495) Wheatland Drive and (T-499) Carriage Lane.

Intersection of (T-495) Wheatland Drive and (T-497) Crest View Lane.

Intersection of (T-497) Crest View Lane and (T-498) Harvest Drive.

Intersection of (T-499) Carriage Lane and (T-498) Harvest Drive.

Intersection of Cannon Lane (T-411) and Colonial Drive (T-410).

Intersection of Homestead Drive and Pioneer Lane (T-527).

Intersection of Cannon Lane (T-411) and Pioneer Lane (T-527).

Intersection of Pioneer Lane (T-411) and Cannon Lane (T-527) - stop signs shall be erected on both sides of Cannon Lane.

Intersection of Crest View Lane (T-497) and Wheatland Drive (T-495).

Intersection of Wheatland Drive (T-495) and West Crest View Lane (T-497)

Intersection of West Crest View Lane (T-497) and West Crest View Lane (T-497).

Intersection of West Crest View Lane (T-497) and Meadow Way (T-413). Stop signs shall be erected on both streets and on both sides of West Crest View Lane.

Intersection of Wheatland Drive (T-495) and Meadow Way (T-413)

Intersection of Crest View Lane (T-497) and Country Drive (T-412)

Intersection of Carriage Lane (T-499) and Country Drive (T-412)

Intersection of Township Roads with State Roads throughout the Township.

**Section 2.** The intersection below is hereby established as a yield intersection, and an official yield sign shall be erected in such a position upon the first-named street as to face traffic approaching the second-named street in the direction or directions indicated. Every driver of a vehicle approaching any such intersection upon the first-named street, in the direction or directions indicated in each case, shall slow down or stop the vehicle and then yield the right-of-way to any vehicle in the intersection or approaching on the second-named street so closely as to constitute a hazard during the time that the driver is moving across or within such intersection.

**Section 3.** Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

**Section 4.** Severability. The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses or sentences.

**Section 5.** Repealer. All provisions of previous Ordinances of the Township of Mount Pleasant which are contrary to this Ordinance are expressly repealed.

**Section 6.** Effective Date. This Ordinance shall take effect five (5) days following its adoption.
